Sub: Promotion to the post of Dy Manager(Telecom) in E-3 Pay Scale.

2. MTNL/CO/HR/R&E/1(110)/2008/KW, dated 19.11.2014.

The 96 Officers who have qualified the LICE and promoted to the post of Dy Manager(Telecom) in E-3 Pay Scale with effect from the date of assumption of the charge of the promoted post vide CO's orders referred above are hereby posted under the units as mentioned in the enclosed annexure. The promoted executives who are already working in the grade of DM(T) in local officiating basis should be reverted back on one day before promoting them on regular basis.

Their promotion shall be governed subject to following conditions.

1. On promotion as Dy Manager(Telecom), these executives are placed on probation for a period of two years in E-3 scale. If their performance are not found satisfactory during this period, their Probation period will be extended for one year and during such extended period they will not be entitled for normal increment.
2. Upon promotion, the Officers are liable for transfer to Delhi, Mumbai or any other place falling in the operational areas of MTNL in the interest of service.
3. Their seniorities will be decided as per Clause No.11 of Recruitment Rule of promotion of AM(Telecom) to DM(Telecom), 2011.
4. The Officers required to join the promoted post within a period of 40(forty) days from the date of issue of CO's order. In case the Officer concerned fails to join the promoted post within the prescribed period of 40 days, he/she should not be allowed to join the promoted post thereafter and the order shall become inoperative and the matter should be reported to this office for further necessary action.
5. Their promotions to the post of Dy Manager(Telecom) shall be subject to the final outcome of Court Case in OA No. 4364/2012 pending before Hon'ble CAT(PB), New Delhi.
6. Those Officers who have already been separated from Company on any account as on the date of issue of this order, their promotion order to the post of DM(T) shall not be effected.
7. It may be ensured that there is no case Vig./Disc. Pending or being contemplated against the officer before allowing them to join to the promoted post.

Necessary charge reports may be forwarded to all concerned.
